Elkhorn Training Camp, LLC ("Elkhorn Training Camp") provides activities, including but not limited to: activities on indoor turf, batting cages, outdoor turf, teaching and mentoring sessions, observations, and use of facilities, premises, and equipment ("Programs and Services").

REQUEST FOR PARTICIPATION OF CHILDREN. I, as parent and next friend, authorize each of my children listed below ("Children") to participate in Programs and Services at Elkhorn Training Camp.

WAIVER OF LIABILITY AND INDEMNIFICATION. On my own behalf, and on behalf of each of my Children listed above, I agree to release and discharge from all liability, and waive all claims, demands and actions against Elkhorn Training Camp and its owners, operators, agents, employees, representatives, vendors and volunteers ("Released Parties"), for any and all personal injury, disability, death, property loss, or damage of any kind which may occur as a result of my Children's presence on the premises, or their Participation in Elkhorn Training Camp Programs and Services, including without limitation any claims, damages, demands, rights of action or causes of action resulting from or arising out of the negligence of the Released Parties or otherwise, while my Children are participating.

I agree to indemnify and hold harmless the Released Parties from any and all liabilities or claims resulting from my Children's participation in the Elkhorn Training Camp Programs and Services. I agree not to bring suit against the Released Parties, and agree to look solely to any first-party insurance for coverage of any damages my Children or I claim. If any provision of this Waiver and Release of Liability is held unenforceable, the other provisions shall remain in full force and effect.

ACKNOWLEDGEMENT AND ASSUMPTION OF RISK OF INJURY. I acknowledge that participation in Elkhorn Training Camp Programs and Services is an inherently dangerous activity that involves the risk of death, disability, personal injury and property damage, and acknowledge and agree to assume such risks on behalf of my Children.

MEDICAL DECISIONS WHILE ON PREMISES. In the event my Children are involved in an accident or incident that requires medical attention and Elkhorn Training Camp is unable to reach me at my emergency contact number below, I authorize my Children's coach or another responsible adult, including any Elkhorn Training Camp personnel present at the facility, to act on my behalf and to be responsible for making all decisions related to medical and survival procedures for my Children, including but not limited to decisions about medical care, the administration of drugs, the performance of life-sustaining procedures, and transportation and admission to any hospital health center or medical clinic. I further acknowledge and agree that the terms of the WAIVER OF LIABILITY AND INDEMNIFICATION provision of this Waiver and Release of Liability shall apply to all decisions made on my behalf by any Elkhorn Training Camp personnel in accordance with this paragraph.

By signing this Waiver and Release of Liability, I certify that I have thoroughly read, fully understand, and voluntarily accept and agree to the terms of this Waiver and Release of Liability on my own behalf, and on behalf of my Children.
